Chula Vista ESD Wellness Policy



The Wellness School Assessment Tool, or WellSAT, was developed by the Rudd Center for Food Policy and Obesity at the University of Connecticut. The WellSAT assesses the quality of a school district's wellness policy in 6 categories, providing two scores in each section and for the overall policy. The Comphensiveness score indicates the extent to which content areas are addressed in the policy and the Strength score describes how strongly that content is stated. Higher scores reflect a policy's broad scope, thorough content, and strong, specific language. These are expressed out of 100, based on component criteria in each section scored from 0-2. A summary of trends and changes since previous analysis and the district's scorecard is available below. In the subsequent pages, each section of the WellSAT analysis is broken down in detail with current and past scores, evidence from the policy, and a section overview.
